# WAURN PONDS SHOPPING CENTRE "SHOP, SCRATCH, SCORE" – BLACK FRIDAY SPEND AND WIN PROMOTION TERMS AND CONDITIONS

- Information on how to enter and prizes form part of these Terms and Conditions.
   Participation in this "Shop, Scratch, Score" Promotion (the "Promotion") is deemed as acceptance of these Terms and Conditions.
- 2. The Promoter is ISPT Pty Ltd (ABN 28 004 582 423) of Level 11/8 Exhibition St, Melbourne VIC 3000.

#### **ELIGIBILITY**

- 3. The following persons are ineligible to enter the Promotion:
  - (a) employees of the Promoter or any of the Promoter's agencies that are associated with the Promotion:
  - (b) the immediate family (spouse, child, parent, sibling) of an excluded employee; and
  - (c) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

# PROMOTION PERIOD

- 4. This Promotion commences at 11:00am local time on Friday 21 November 2025 and closes at 3:00pm local time on Monday 1 December 2025, or until all 1,100 Scratch Cards have been distributed, whichever is first (" **Promotion Period** ").
- The Participating Centre is Waurn Ponds Shopping Centre ("Participating Centre").
   A "Participating Retailer" means any retailer at the Participating Centre. An "Ineligible Transaction" means any transaction recorded on an invalid receipt (as specified in Clause 7 below).

## **ENTERING THE PROMOTION**

- 6. To enter the Promotion, entrants must, during the Promotional Period:
  - a. Spend \$75 or more (combined) at any Participating Retailer(s) in a single day ("Qualifying Spend"). In the event purchase receipts are not automatically provided to the entrant by a member of staff at the time of making their purchases that make up a Qualifying Spend, it is the entrant's responsibility to request one. For the avoidance of doubt, amounts spent on Ineligible Transactions will not contribute to the Qualifying Spend.

- c. Staff will verify and stamp receipts to confirm they have been used for the purposes of this Promotion
